

STATE FIELD CHAMPIONSHIP GUIDELINE

Updated 2015

HOST CLUB INFORMATION

The Tournament Committee will handle the advertising and pre-registration for the tournament.

The first day's shooting time will be at 10:00 a.m. – shotgun start.

The second day's shooting time will be at 9:00 a.m. – shotgun start.

The following information must be supplied to the Tournament Committee Chair for publication:

Directions to range

Area accommodations (motels, camping)

Club contact name and phone number for further assistance with directions and accommodations.

REQUIREMENTS:

28-target Field Range set up in two 14 target units, staked for field and hunter rounds OR 14-target Field Range staked for field and hunter rounds.

The host club must furnish an adult to chaperone cub shooters – one for every four cubs.

NFAA OFFICIAL TARGET FACES ARE TO BE USED FOR THE TOURNAMENT.

Must glue paper targets on cardboard.

Provide drinking water at a minimum of each 14 targets.

FEES:

Adult/Young Adult: \$35.00

Youth/Cub \$20.00

Family \$90.00

Professional: \$65.00 (\$30.00 pro purse in addition to registration fee)

ROUNDS:

Day 1 28 Field Day 2 28 Hunter

These rounds are to be shot according to the guidelines published in the NFAA Constitution and By-Laws.

SCORING:

There must be a minimum of 3 archers in each shooting group.

Field:

Inner Black 5

White 4

Outer black 3

Hunter:

White 5

Inner Black Ring 4

Outer Black Ring 3

The arrow must touch the line for the higher score

Scorecards:

The total score for each end, the total round score for each day, and the total score at the completion of both rounds shall be recorded.

There will be duplicate scoring. Two archers are chosen to be scorekeepers, one archer will call the value of the arrows, and one archer will be target captain. The target captain is responsible for the final decision on arrows if there is a questionable one. If the target captain cannot make a determination, then the line judge will make the final decision.

Arrows and scoring face are not to be touched until all arrows are scored and recorded.

Shooting the Round:

Practice ends will be determined at the discretion of the Tournament Chairman.

Those archers whose targets are in the lower position will shoot first. After the completion of a 14 target unit, the archers will switch positions and those who shot the lower position will now shoot the top position, and vice versa, the archer that shot the right position will shoot the left position, and vice versa.

An archer is not entitled to repeat a shot unless the mis-shot arrow can be reached by the bow from the archer's position on the shooting line.

Unsuspected pass-throughs will be re-shot after all rounds have been completed for that day.

Any arrow that has passed through the target face in such a manner that it can easily be pushed back through and scored may be pushed back through AFTER ALL ARROWS IN THE TARGET HAVE BEEN SCORED AND RECORDED -- IF ALL TARGET MATES ARE IN AGREEMENT. If the arrow is hanging from the back of the target at an angle and cannot be easily pushed back through and scored, or if all target mates are not in agreement, this must be treated as an unsuspected pass-through and re-shot as noted above.

If an archer shoots more than the prescribed number of arrows in an end, only the prescribed number of arrows of lower value will be scored. A penalty of one point will be assessed for each arrow shot over the prescribed number.

Hits on the wrong target will be scored as misses.

In the event of equipment failure, the archer will have 45 minutes repair time. One practice end to re-sight will be allowed. The archer shall be allowed to shoot any arrows he or she did not shoot during the repair time after the final end.

FLIGHTING:

NFAA flighting system will be used for class/styles with 10 or more archers. Archers will be placed in flights after the first day's round is completed, and will remain in these flights for the duration of the tournament.

TIES:

All ties for the top three places will be shot off. The method will be determined at the discretion of the Tournament Chairman.
