

Board of Directors Meeting/ 68th Annual convention

The IAA Board of Directors meeting was held Nov. 7, 2021 at Pizza Ranch in Springfield. M.J. Rogers spoke about his adaptive outreach program.

The meeting was called to order at 10:12 A.M., followed by the pledge of allegiance. Chairman, Mike Clary, seated officers and resignations were accepted as of Sept. 1, 2021 from Cassie Flood and Randy Rutledge. Roger Nieders was reassigned and Bill Kingore and Colleen Dracos were appointed as new representatives.

Roll call of officers was taken with the following present; NFAA Director, Robert Rayhel; Chairman, Mike Clary; Northern board, Rick Knorr; Central board, Roger Nieders, and Kathy Pindell; Southern board Patrick Eller. Board members Bill Kingore, Don Craig, and Judy McCutcheon-Adams were absent. Delegate Ron Whitlock was in attendance.

The minutes of the last meeting were distributed to the board members in advance and were accepted. The financial statements were accepted as published.

Director Robert Rayhel reported on information from the NFAA Board meeting and reviewed the action taken on agenda items presented at the meeting. He also reported on The Vegas Shoot (Feb. 3-6), NFAA Nationals in Louisville (Mar. 18-20), and IL State NASP tournament (Apr. 1-2, 2022) in Springfield.

Awards committee- have adequate supply of patches and medals

Convention committee- location for 2022 convention

Constitution committee- Rick reported work on updates

RIC, Membership/Club Retention, Bowhunting and Conservation, Youth, and Tournament committees had no new reports.

Committee appointments were made by Chairman, Mike Clary.

In new business, aggregate awards were discussed and plaques will be given.

Discussion was held on the 2021 Shooter of the Year awards. Since the State Field was canceled it was voted to not have Shooter of the Year for 2021.

Tournament bids for the State Indoor Target Championship were voted on and it will be held at Presley's Archery.

Sara Rayhel was retained as secretary.

State tournament fees were discussed. A motion to raise the fee to \$40 for adults/young adults and \$30 for youth/cub carried.

The need for a new printer that can run scorecards was presented. A motion to buy a new printer passed.

Following the meal, Colleen Dracos was in attendance and accepted the position of Southern board member. A role call of delegates was taken with Buckskin Legacy, Panther Creek Bowhunters, Pekin Archery, Wenois Field Archers, and Wolf Run Bowhunters represented.

A need to change how tournament bids are awarded was expressed by Chairman, Mike Clary. Further discussion will follow at the next meeting.

The 2022 aggregates will be at Wenois for Central zone and Buckskin Legacy for Southern zone. The 2023 aggregates bids are postponed until summer of 2022. State Field Championship will be at Panther Creek Bowhunters on August 27-28, 2022 and State Target Championship will be hosted by Buckskin Legacy on Sept. 10-11.

The next meeting will be April 3, 2022 in Springfield.

Meeting adjourned at 1:18 PM.
