Directions to Range: Traveling south on I-55, take the Divernon exit (#80). Turn right at top of ramp, take the first left (at frontage road). Take frontage road south approximately 4 miles to Virden Rd., turn right. Proceed to stop sign, turn right at stop sign and follow road approximately 3 miles to range. Traveling north on I-55, take the Farmersville/Girard exit (#72). Turn right at the top of the ramp, cross the highway, and take the first right (at frontage road). Take frontage road north approximately 4 miles to Virden Rd., turn left. Proceed to stop sign, turn right at stop sign and follow road approximately 3 miles to range.
