## **ADDITIONAL RAFFLE INFORMATION**

IAA Board of Directors and the members that were present at the convention in March have decided to hold a Gun Raffle to raise money for the organization. This will enable the organization to do more things to promote itself and the sport that we all love.

Tickets for guns are easy to sell Guns go up in value; Bows go down in value and there are a lot more gun owners/collectors out there than archers.

Ticket Prices are \$15.00 each.

Tickets go on sale in May. First drawing will be in December of this year. We have to sell 600 tickets before the drawings will start. If we do not sell at least 600 tickets, it will become a 50/50 drawing.

Guns will not be purchased until after each drawing. Winner may want cash instead of the gun for that month. If the winner chooses the gun, there may be a delay in delivery of the gun due to some shortages from manufacturer according to the firearms dealer we are working with.

Only 2000 tickets will be printed which will increase the odds of winning. Ticket will go back into the bucket for the next drawing so 1 person has the potential to win all 12 guns for an investment of \$15.00.

Bill Mohn and Bill Schuh were appointed at convention to administer the raffle for the IAA.

Club contact will order tickets from Bill Mohn.

Club contact will distribute tickets to club members. They know the members and can better control tickets and money.

Club contact will collect the ticket stubs and \$\$ or checks. Please make checks payable to IAA for amount collected.

Seller puts their name on the back of the ticket stub that they sell. For every 5 stubs that you sell, seller will be put into the drawing once for one \$500 prize.

Each member needs to turn in their sold ticket stubs by the 15<sup>th</sup> of the month for the next months drawing.

Tickets can be sold to non-Illinois residents. IL residents will require a FOID card to accept a gun. Non IL residents will need to make delivery arrangements with their local FFL gun dealer to receive any guns won.

## I.A.A. Fund Raiser Update for June

I thought I would try to give an update on our fund raiser every once in a while; maybe each month. As of June 15th here is what has been accomplished:

1. All clubs have been contacted and informed of how to get raffle tickets for their members and what to do with the ticket stubs and the money after the members sell the tickets.
2. All members who are not shown in the IAA records of being a member of an IAA club were sent 5 tickets with instructions on what to do with the stubs and money and how to get more tickets if they need them.
3. 72 ticket stubs and \$1080 have been turned in to me so far.

I would also like to take time to clarify some things we did not communicate well the first time around. Some people thought that only a few people in the IAA were supposed to be selling the raffle tickets. That was never the plan. We need all members to help with this fundraiser. The intent was for everyone to help a little so that no one has to do a lot. If everyone will sell or buy 5 tickets this project will be a success.

If you are in a club, you need to get your tickets from the person in your club who has them. If you don't know who that person is, please contact me or Bill Mohn. After you sell your tickets, you need to return the stubs and money to your club contact person who gave you the tickets.

If you are not in a club you should have received 5 tickets from me in the mail. When you sell them you need to return them and checks to me. If you need more tickets, let me know and I'll send them to you.

Another benefit of this raffle is that we are being made aware that our records for club membership are not as accurate as they could be and a few of you who are members of clubs also received 5 tickets from me. If you will let me know what club you are in I will let Dixie know so she can update the records. Or you can just contact Dixie yourself.

Thanks to all who are helping with this new concept for growing and improving our organization. There is plenty of time left for everyone to help. We have 2,000 tickets to sell so that means we only have 1,928 to go. And don't forget, for every 5 tickets you sell, you get your name in the drawing 1 time for \$500. The more tickets you sell the more times your name will be in the drawing.
