The IAA convention was held March 10, 2013 at the Motel 66 Convention Center in Springfield. The general board and delegates meeting started at 10am with about 20 members attending.

Tournament bids were accepted by the tournament committee and are listed in this bulletin. Please note the change in the date for the State Field Championship to August 17 & 18, 2013.

NFAA Director, Judy McCutcheon reported on some of the NFAA agenda items and they can be viewed on the NFAA web site. The new agenda items will be effective June 1, 2013.

Dave Woods reported on the NASP program stating that there would be about 700 youth participating in this shoot.

The Big Game Outstanding Kill went to George Zanoni for his mule deer. Pat Whitlock received the small game award with a skunk and Robert Rayhel received the doe award.

The outdoor and indoor aggregate awards were presented to those present.

A constitutional change needs to be made regarding the number of voting member attending a meeting. The board voted to have an electronic ballot and a copy will be published for 2 months before the ballot will be voted on.

The board also voted to rehire Dixie Garner as the IAA secretary for another year.

The IAA Board of Directors and Delegates meeting was held March 10, 2013 at the Motel 66 and Convention Center in Springfield. The meeting was called to order by chairman, Dave Woods at 10:10am.

After the pledge of allegiance, roll call of officers was taken with the following present, Chairman Dave Woods; NFAA Director, Judy McCutcheon; northern board, Rick Knorr and Bill Berger; central board, Mike Lantz and Bill Mohn; southern board, Ron Whitlock, Bill Schuh and Robert Rayhel. Chairman, Dave Woods called for a moment of silence for the loss of our NFAA Councilman, Robert McCutcheon.

A letter of resignation was read from Walter Erickson effective on March 10, 2013. Tim Ward volunteered to accept his position. A motion was made by Ron Whitlock, 2nd by Mike Lantz to accept the resignation and accept the appointment of Tim to fill the office until November 2014. Motion carried.

The minutes of the last meeting were passed out to the board members in advance and Ron Whitlock made a motion, 2nd by Mike Lantz to accept as published. Motion carried.

The financial statements were accepted as printed with a motion by Ron Whitlock, 2nd by Bill Berger.

A discussion on the gun raffle with the income and expenses, and the expenses for the NFAA Director was held, after explanation Mike Lantz made a motion 2nd by Tim Ward to accept.

There were no reports from the convention, RIC, and the constitution committee. The Bowhunting chairman Robert Rayhel reported that there will be some changes at the DNR this next year. Robert Rayhel and Bill Mohn reported about the 4-H instructors training session. Bill Schuh reported that we need to have younger people to step up and help.

IAA Secretary, Dixie Garner gave a short report on some dates and requirements of charters, bulletin deadline and insurance.

NFAA Director Judy McCutcheon gave a report on some of the agenda items discussed at the NFAA Convention. The new agenda items will be effective June 1. The agenda items passed can be viewed on the NFAA web site. Judy also reported that no date has been set for the Nationals.

Chairman, Dave Woods reported on the NASP shoot and set up times. Dave reported that there will be about 700 youth shooting this event. Donating bows for this event were Joliet Archery Club, Ron's Bow Shop, Buckskin Legacy and Prairie Archery. The IAA will donate a bow and arrows.

A discussion was held on purchasing a trailer to hold the targets and supplies to be used for demonstrations. Dave Woods reported that he had found a trailer and the board need to decide what size they needed. Robert Rayhel made a motion, 2nd by Ron Whitlock to spend up to \$5000.00 on the trailer. A discussion followed with what to do with the targets that were stored in the old trailer. Randy Rutledge suggested that they give the targets to Robert Rayhel. Bill Mohn made a motion, 2nd by Bill Schuh to purchase 4 new 37 x42 targets. It was suggested that we purchase 4 Genesis bows and 4 doz arrows not to exceed \$600.00 for the bow and arrows to be used for demonstrations. Motion carried.

After breaking for lunch at 12pm the meeting was called to order at 1pm.

A discussion was held on the shooter award. Medals will be given for 1st, 2nd and 3rd for the championship shoots. Ron Whitlock made a motion, 2nd by Robert Rayhel to use the state of Illinois shape for the yearly plaque. The plaque will list the 3 state shoot on a calendar year.

Dave Woods reported that the web site was about ready and would have a link to order IAA merchandise and the IAA would receive 10% on the purchase. He also reported if you have something you want published to send it in word or excel.

The next board meeting was set for June 29, 2013 at Pekin Archery Range following the State Target and November 3 at 1pm.

Rich Knorr reported that a constitutional change needs to be made regarding the number of members needed to hold a quorum for our meetings. Robert Rayhel made a motion, 2nd by Mike Lantz to have an electronic ballot. Motion carried. Bill Schuh made a motion, 2nd by Robert Rayhel to lower the quorum to 5 voting members. Motion carried. The ballot will be advertised for 2 months in the bulletin.

The tournament bids were received and the winning bids locations are listed in the coming events. The indoor championship bid must be received before the June meeting.

The names of the winners of the indoor aggregate, outdoor aggregate and the bowhunting awards were announced and plaques given.

The secretary position was discussed and Dixie Garner accepted the position for another year for the same salary and was given a \$500.00 bonus.

Mike Lantz made a motion to adjourn, 2nd by Bill Berger. The meeting and convention adjourned at 2:20pm.

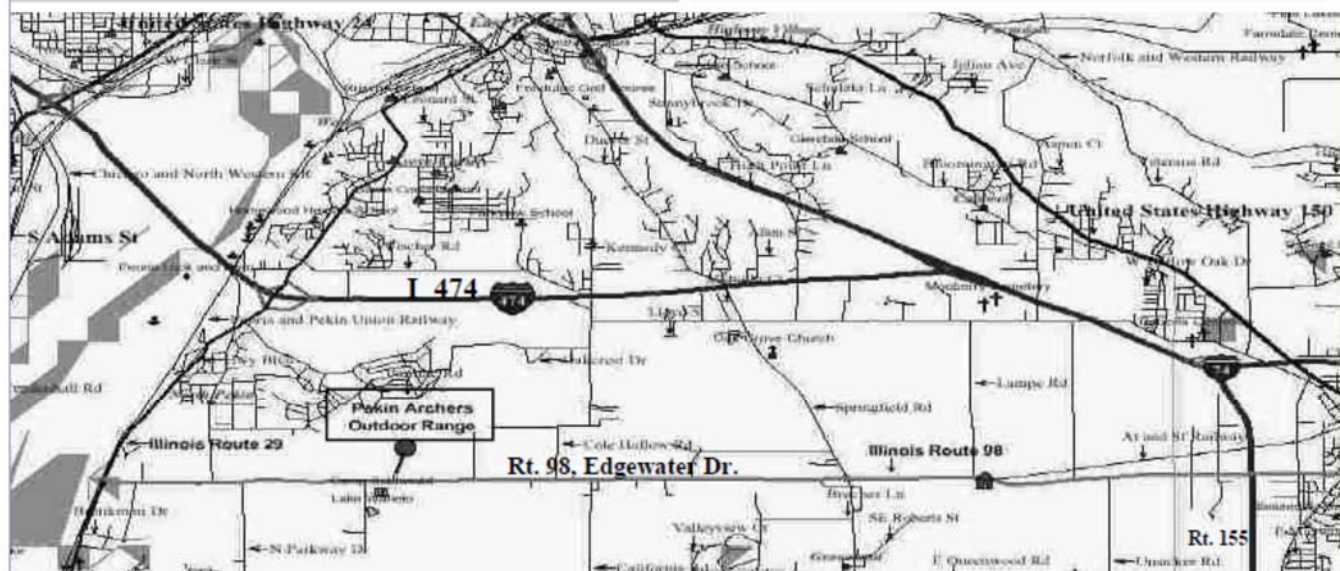
