The IAA Board of Directors and Delegates meeting was held March 9, 2014 at the Motel 66 and Convention Center in Springfield. The meeting was called to order by the Chairman, Robert Rayhel at 10am.

After the pledge of allegiance, roll call of officers was taken with the following present, Chairman, Robert Rayhel; NFAA Director, Judy McCutcheon-Adams; northern board, Rick Knorr: central board, Bill Mohn; southern board, Ron Whitlock, Bill Schuh and Tim Eller. Also present was the past chairman, Dave Woods. Roll call of the delegates was taken by the chairman, Robert Rayhel.

The minutes of the last meeting were passed out to the board members in advance and Ron Whitlock made a motion 2nd by Tim Eller to accept as published. Motion carried.

The financial statements were accepted as printed with a motion by Ron Whitlock, 2nd by Tim Eller. Motion carried.

NFAA Director, Judy McCutcheon-Adams gave a report on some of the agenda items discussed at the NFAA convention. The new agenda items will be effective June 1. The agenda items passed can be viewed on the NFAA web site.

There were no report from the convention, RIC, constitution and membership committee. A discussion was held on the awards, and the youth shoot. Tim Eller and Bill Mohn reported on the 4-H program.

IAA Secretary, Dixie Garner gave a short report on some dates and requirements of charters, bulletin deadline and insurance. Bill Mohn made a motion, 2nd Bill Schuh to remove the charge of \$10.00 for clubs to include fliers in the bulletin. Motion carried.

Robert Rayhel and Dave Woods reported on the NASP shoot. Set up time will be Friday and shooting will start at 8AM on Saturday March 22. Robert reported that there will be about 800 youth shooting this year, with 4 or 5 new schools participating.

Chairman, Robert Rayhel reported on the trailer, stating that the trailer had insurance, license and is ready for use. Bill Mohn made a motion, 2nd by Ron Whitlock to have a new banner made to attach to the side of the trailer when it is in use at an event. Motion carried.

A discussion was held about the amount of money in the checking account, and was voted to leave it for now and discuss at the next meeting.

Chairman, Robert Rayhel reported that he has been in contact with the Hitting Center and the orr building, looking for a place to hold the state tournament. This will be discussed at the next meeting.

A discussion was held on the new trophies and Ron Whitlock made a motion to raise the adult, youth and aggregate fees \$5.00, and the family rate to \$80.00, 2nd by Tim Eller.

Bill Schuh reported on the new laws regarding the gun raffle. Bill will check on the laws and report back at the June meeting.

Tournament bids were received and the winning bids locations are listed in the coming events.

The meeting dates for 2014 were set for June 14 and November 9.

Chairman, Robert Rayhel thanked Dave Woods for his 22 years' service as Chairman of the Board.

Ron Whitlock made a motion, 2nd by Tim Eller to hold the state tournament as a 2 day indoor 300. Motion carried.

Tournament Chairman, Judy McCutcheon-Adams and the board members passed out the trophies for the aggregates and state shoots winners.

The secretary position was discussed and Dixie Garner accepted the position for another year for the same salary and was given a \$500.00 bonus.

Ron Whitlock made a motion to adjourn, 2nd by Bill Mohn. The meeting adjourned at 1:30pm.
