Board of Directors Meeting

The IAA 69th Annual Convention and Board of Directors meeting was held Nov. 6, 2022 at Pizza Ranch in Springfield. The meeting was called to order by the Chairman, Michael Clary at 10:00 A.M. Pledge of allegiance was led by Mike. Roll call of officers was taken with the following present; NFAA Director, Robert Rayhel; Chairman, Michael Clary; Northern board, Rick Knorr, Otto Hrad; Central board, Roger Nieders; Southern board Patrick Eller and Colleen Dracos. Bill Kingore, Don Craig, Kathy Pindell, Ronda Scott, and Judy McCutcheon-Adams were absent. Others attending were Travis and Carley Brown.

Awards were presented for 2022 Shooters of the Year, Travis Brown and Kathy Pindell; Big Game, Terry Wunderle; and aggregate winners Patrick Eller, Ronda Scott, Mike Clary, Mike Lantz, Neal Hause, and Sam March.

Director Robert Rayhel reported the Great Lakes Indoor Sectionals registration will be online with Sports80. Clubs will receive the registration list and set line times. Outdoor Sectionals will be discussed at next directors' meeting. Surveys were sent out from NFAA regarding experiences and opinions on archery. A website is being introduced by NFAA covering information from each state. A transgender policy based on original birth certificate is to be voted on by directors at their next meeting. Organization of NFAA youth clubs and certification of coaches was discussed. A youth club is formed of 4 or more youth and an NFAA adult member by submitting the NFAA club application with \$55 charter fee to the IAA secretary.

Committee appointments were reviewed and revised by Chairman Michael Clary. Convention, Constitution committee, RIC, and Membership/Club Retention committees had no new reports. Bowhunting and Conservation- hunt teams need to get registered. The deadline is the last day of archery deer season and registration of \$10 per team member should be sent to IAA secretary.

Awards committee reported sufficient quantity of medals, patches, and pins. Sara will report quantity of each award and committee will continue investigating suppliers for various types of awards.

Travis Brown talked about sources of information for youth programs.

After a lunch break, the minutes of the last meeting were accepted as published with a motion by Otto Hrad, 2nd by Colleen Dracos. The financial reports were discussed and accepted with a motion by Roger Nieders, 2nd by Rick Knorr. The roll call of delegates was taken with the following clubs represented: Buckskin, Effingham Sportsman, Kennekuk, North Side, Panther Creek, and Wenois.

In old business, the bid was accepted for the Indoor State Championship to be held at Presleys Outdoors in Bartonville. It will be advertised as the first leg for the Shooter of the Year.

Aggregate locations and dates were discussed. The southern zone aggregate will be hosted by Effingham Sportsman Club on Jan. 21-22 and Feb. 11-12, northern and central aggregates to be determined.

The tournament committee accepted clubs for the following shoots: State Field at Panther Creek, August, 2023; Indoor 2024 aggregates- Northern zone at North Side Archery, Central zone at Wenois, and Southern zone at Effingham.

The next Board meeting will be March 5, 2023. The vote passed to move the next convention date to the spring and not have a fall convention in 2023 on a motion by Robert Rayhel, 2nd by Otto Hrad. The next convention date is March 3, 2024.

A motion was made to adjourn by Patrick Eller, 2nd by Otto Hrad. Meeting adjourned.
